Brethren... Did vou know? Well. vou know our current Lodge dues are \$84. but did vou know we don't receive the full benefit of this money? Our by-laws state that every member shall be charged \$56, plus Grand Lodge dues and assessments. Grand Lodge dues and assessments are now \$28 (or 1/3 of the dues), and must be

paid for each member on the rolls. The math is simple; multiply our membership times 28; the answer is what we must send to Grand Lodge (we have well over 400 members; again, the math is simple). My point is this; we must soon send our Lodge's dues to Grand Lodge, which comes from our general operating fund. On what is left over. we operate on for the remainder of the calendar year. Other than a portion of degree fees collected, donations contributed to help offset meals, or other special offerings; the Lodge survives solely on the income from our annual dues. (By the way, please realize that if Grand Lodge assessments increase, your Lodge dues will increase accordingly.)

This being said, it is important to note; if you have not vet sent in your 2009 dues, the Lodge must still send \$28 for you to the Grand Lodge. We have no choice; it is due and payable for our membership. So, those who have paid their '09 dues are also covering the per-capita taxes for those who have not. Respectfully I must ask, is this fair? Furthermore, and most regrettably, for those who have not yet paid their "2008" (or earlier) dues, the Lodge has already paid the taxes for that year too. My brethren, "in a most friendly manner," your Lodge is in need of current dues to operate successfully.

Be reminded, accurate records are important for the administration of the Lodge. Please keep me informed of anticipated address and telephone number changes so I can keep the records up to date. (E-mail works for quick contact; you may send me an e-mail and I will respond to you promptly - send to: rstanek1@cox.net)

If you know of any brother in need of special assistance regarding any matter, please contact the Worshipful Master or me, for as you know, one of the most important principles of Freemasonry is charity.
