#### From The East



Fraternity. Our organization is often referred to as a Masonic fraternity. I was reflecting on this today and found this definition of the word Fraternity: "A brotherhood and group united in common interest and activity." This

aspect of being united refers to all of us coming together in some way. Sadly, fraternal organizations like ours are a dying breed, diminishing in both number of members and the level of participation by those who do belong to lodges. Just a couple of days ago I read an article in the national news regarding the struggles of The Shrine. It seems that, for the first time in their history, the Shriners will have to close at least a guarter of their hospitals. What is occurring on the national level is also occurring within all community organizations, including ours. We currently have around 470 members. With respect to lodge participation, my review of our participation trends reveals that only about 40 to 60 members are conducting the entire business of the lodge. More specifically, about 18 brethren are completing about 90% of the total work at Kempsville.

I am writing this the night after RW Matt Szramoski, Chair of the Grand Lodge Committee on Finance, gave a rousing speech at the Kempsville Stated on "Lodge Solvency in the 21st Century." Some key points from this talk include: (1) a total decrease in Masons in Virginia of 31,000 between 1969 (71.000) and 2008 (40.000) - in spite of an overall population increase of 3.5 million Virginians during that same time period; (2) a lack of younger members in ALL fraternal organizations (due an increase in overall family demands and because males under the age of 50 now work an average of 17 more hours per week than males did during the heyday of Freemasonry immediately following WWII); (3) decreased involvement in Masonic youth organizations; and (4) continued decline in the number of wives belonging to the OES, Amaranth, etc.

Kempsville, however, is blessed in many regards. We still maintain a large number of total duespaying members. Our overall membership in recent years has remained fairly stable. Our youth

organizations are actually thriving and growing in numbers. We are attracting younger brethren to the lodge. Kempsville has a rich tradition in all areas important to masonry – fellowship, ritual, and community service. In all, Kempsville is a lodge with a lot of heart.

All of this leaves me with confidence about how we will face two issues critical to maintaining the viability and solvency of Kempsville Lodge #196 – (1) eliciting the participation of inactive members, and (2) sustaining the financial health of the lodge in forthcoming years.

As stated in the "Lodge Membership Revitalization Resource Guide," the important task is for each lodge to make an ongoing effort to its members to make the percentage of inactive members a minority, rather than a majority. If this is done, the lodge will benefit in the following ways: More members available to serve as officers on committees; a larger pool of brethren to draw from to assist with conferring the degrees; a more stable financial base for the lodge with decreased NPDs and demits; with inactive members attending lodge and more families coming to open functions the word will spread and a positive attitude will grow!; and the officers will have less (not more) work to do (Many Hands Make Light Work!).

This will require immediate action with all of us officers and brethren – pulling together in solidarity. I am proposing the following three part plan of action. First, we will appoint a Survey Committee who will be tasked to discover the reason (and not the opinion) for why many members of the lodge have not been active. Secondly, we will be distributing (via email, the Ashlar, and handouts at lodge) a sign-up sheet entitled "150 Ways You Can Help the Lodge." Research has revealed that if you do not assign a new brother a task to help the lodge within the first 6 months of his being initiated, he will likely become an inactive member. Lastly, we need to increase our dues. For the past 10 years, our lodge dues (not counting the assessment portion which goes to grand lodge) have been unchanged at the reasonable rate of \$56 per member. This per member lodge membership fee of \$56 is lower than most lodges and has not been adjusted to

account for normal increases in inflation. I am proposing an increase of \$6 per member (a 50 cent increase per month) so that the lodge portion of the dues will be \$62 annually. Coupled with the Grand Lodge assessment of \$28, this will make the 2010 total dues \$90 (instead of \$84). My good brethren, I promise you that my heart is in the right place with these ideas. One of my key responsibilities as Worshipful Master is to protect the lodge and make sure that it is set for the immediate and distant future. I look forward, with the best of intentions and integrity, on making these changes happen together with you.
